Please protest the recent Pest Management Regulatory Agency's decision to ban the use of Strychnine chemical to control Richardson's ground squirrels (gophers).

It is only through the use of this product that we have finally been able to reduce the exploding populations which cause millions of dollars annually to farmers.

In the last 70 years of using this product I saw only two non-targeted species being affected - a raven and crow - who themselves were deemed undesirable in the past - with municipal bounty being paid for their elimination due to their destruction of other birds nestings, etc.

Re: Re-evaluation Decision RVD2020-06, Strychnine and Its Associated End-Use Products (Richard's Ground Squirrel)

Health Canada's Pest Management Regulatory Agency has published the re-evaluation decision (RVD2020-06) regarding strychnine and its associated end-use products, which was published March 4, 2020.

Health Canada is cancelling the registration of strychnine, and all associated end-use products, used to control Richardson's ground squirrels for sale and use in Canada. To comply with this decision, products that are cancelled with be phased out following the implementation timeline outlined below.

- Strychnine sales by registrant are prohibited after March 4, 2021, followed by:
- Strychnine sales by retailer are prohibited after March 4, 2022, followed by:
- Strychnine possession and use by end-user is prohibited after March 4, 2023.

What are your next steps?

If your county or municipality holds a vendor registration permitting the sale of strychnine, please email Tanya Rushcall (contact information below) with your current registration number.

After March 4, 2022, Alberta Environment and Parks will need to remove the ability to "sell and distribute (store) pesticides at Retail (Pesticide Sales and Distribution shall be limited to formulations of STRYCHNINE)" from vendor registrations.

This will result in either a cancellation of your vendor registration (if you were only selling strychnine products) or an amendment to your vendor registration (if you were permitted to sell other products (e.g. Rural Acreage Owner)).

For counties or municipalities who have indicated they hold a vendor registration permitting the sale of strychnine, you will receive an additional notice after March 4, 2022 for further action at that time.



Application Directions - Ground Squirrels: Hand Bailting: Locate all the ground squirrel burrows in the area of treatment and place 7 to 14 grains (0.25 to 0.55 ources) of bail into each burrow. Re-visit the sits within 48 hours and re-bailt all burrows where bailt has been consumed or removed. A third re-bailing visit may be necessary for control. Do not re-bail burrows where the bail is undisturbed. Remove and bury any squirrel carcasses which are present above ground.

Balt Station Balting: Determine the approximate population present by visual count over a two-day period. In areas where ground squirrels are present, establish protected bait stations or tamper resistant boxes with an entrance hole of 7.6 cm (3 inches) using 1 station for every 50 animals counted. Place 500 grams (7.6 boxnos) of balt into the stations and check they. Maintain an uninterrupted supply for 3 weeks or until all signs of feeding have stopped. In areas where ground squirrels have been known to inhabit, but are not currently present, preventative balling in stations can be accomplished by placing stations containing 500 grams (17.6 ounces) of balt every 30 to 60 metres (100 to 200 feet). Replace spoiled or molely bait as necessary. Remove and bury any squirrel carcasses which are present above ground.

USE LIMITATIONS - Ground Squirrels:

Batt placed outdoors and above-ground in residential areas, public areas, or any other sites that are or will be open to the public (for example, Pick-Your-Own sites) or in locations accessible to pets or livestock MUST be placed in Tier 1 batt stations.

Tier 1 bait stations must have the following characteristics:

- constructed of high-strength material (e.g., metal or injection-moulded plastic) and resistant to destruction by children and non-target animals;
- 2. have an entrance designed so that children and non-target animals cannot reach the balt;
- 3. have an internal structure that prevents balt from being shaken loose;
- 4. have an access panel which fastens securely and locks (e.g., metal screw or padiock);
- 5.bear the product name, active ingredient, guarantee, registration number, "WARNING POISON", and the skull and crossbones symbol.
- 6. be resistant to destruction or weakening by elements of typical non-catastrophic weather (such as, snow, rain, extremes of temperature and humidity, direct sunshine, etc.).


POCKET GOPHERS: (Thomomys spp. and Geomys spp.):

Areas of Use - Pocket Gophers: Pocket gophers throw out low, fan-shaped mounds on either side of their underground burrows. These lateral tunnels come to the surface and are on the concave or flat side of the fan, and the entrance holes are plugged with loose soil.

Application Directions - Pocket Gophers:

Placement of the bait can be made in any of the following ways.

- 1. With a Long-handled spoon, carefully remove the plug on the flat ide of the fan, Carefully Insert 15 grams (0.53 ounces) of balt as far down into the hole as possible. Replace the soil plug to close the burrow, with care so that the balt is NOT covered with soil. Make 2-3 balt placements per burrow system. Bury dead animals and spilled balt found on soil surface immediately. Maintain a constant supply of balt in the burrow system for as long as there is pocket gopher activity. Do not apply bett on the surface of soil.
- Using a metal rod, probe 15 to 20 centimetres (6 to 8 inches) deep to locate the main tunnel. Consult diagram below for location to probe. Drop 15 grams (0.53 ounces) of bait into the tunnel and cover the hole so light will not enter the tunnel system.



The right and the wrong ways to use a probe for placing pocket gopher batt are shown, Bait should be placed loosely in the main runway - not in the lateral tunnels or embedded in the bottom of the runway.

Make 2-3 bait placements per burrow system. Bury dead animals and spilled bait found on soil surface immediately, Maintain a constant supply of bait in the burrow system for as long as there is pocket gopher activity. Do not apply bait on the surface of soil

- 3. Machine application using "burrow builder" equipment: Foliow manufacturer's instructions for the equipment used to apply this bait. Make artificial burrows at the same depth as natural burrows, about 4.6 to 9 metres (15 to 30 feet) apart. Apply 1.7 to 4.5 kilograms of bait per hectare (1.5 to 4 pounds per acre). Use the high rate in locations with greater pocket gopher activity. Apply when soil conditions allow formation of good artificial burrows. Do not treat the entire field. Apply as:
- A targeted treatment to the part of the field where pocket gophers have established burrows, Make 6 to 8 rows in the
 area infested with pocket gophers. Do not exceed 3 applications per year.
- Perimeter treatment to reduce potential migration of pocket gophers into the field. Make 3 rows around the perimeter of the field. Use only in localises where there is a risk of pocket gopher damage. Do not exceed 3 applications per year, one each in the fall, spring and mid-summer.


