

**SMOKY LAKE COUNTY  
IN THE PROVINCE OF ALBERTA  
BYLAW NO. 1167-08**

Being a Bylaw of the Smoky Lake County, to authorize the Municipal Council to enter into an Agreement to establish **the Smoky Lake Joint Economic Development Initiative** Committee, for the purpose of promoting the development of a diversified economic base in the Smoky Lake County.

**WHEREAS** the Municipal Government Act, S.A. 2000, as amended ("the Act") provides that a Municipal Council may pass such bylaws to enter into an agreement as to the joint control and management of anything that concerns respective municipalities.

**NOW THEREFORE** the Council of the Smoky Lake County, duly assembled, enacts as follows.

**1. PURPOSE**

Through its collaborative efforts, the Smoky Lake Joint Economic Development Initiative aim to promote, facilitate and support economic development and tourism initiatives within the Smoky Lake County Region (Smoky Lake County, Town of Smoky Lake and the Villages of Vilna and Waskatenau).

**2. MEMBERSHIP**

**2.1 Municipal Representation (Voting Members)**

Smoky Lake County – three Councillors  
Town of Smoky Lake – two Councillors  
Village of Vilna – one Councillor  
Village of Waskatenau – one Councillor

Any changes to the above structure must be authorized by all of the participating municipalities.

**2.2 Support Staff**

**Secretary** – Planning & Communications Manager,  
Smoky Lake County

**Resource** - Community Economic Development Coordinator,  
Community Futures St. Paul – Smoky Lake

**2.3 Other Participation**

The Committee, at its discretion, can elicit such other non-voting participation as it deems necessary from time to time.

**3. OBJECTIVES**

The objectives of the Joint Economic Development Initiative are to:

- 3.1 Prepare Plans and recommend Programs which will maintain the desired level of regional growth;
- 3.2 Recommend Programs that encourage the proper use of the region's resources;
- 3.3 Contribute to the regional planning efforts by preparing data and studies that will accurately reflect the present situation and expected directions of the region's economy;

- 3.4 Recommending projects and priorities which meet the region's needs;
- 3.5 Assisting in local implementation of Provincial and Federal Programs to promote regional development;
- 3.6 Strive to expand the economic base of the Smoky Lake Region;
- 3.7 Perform an Annual Review of Regional Strategic Plan; and
- 3.8 Provide a leadership role in the implementation of projects initiated as supported collectively through each municipal Council.

**4. ADMINISTRATION**

**4.1 Budgets**

Budgets shall be prepared annually by the Committee and presented to each respective Council for approval.

**4.2 Financial**

Finances shall be administered by Smoky Lake County and billed as per the approved funding formula.

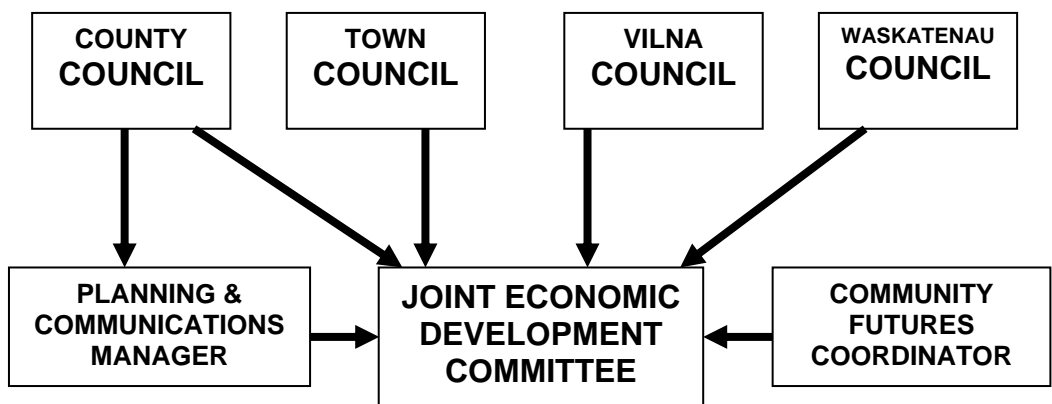
**4.3 Funding Formula**

Unless otherwise negotiated, all project funding contribution shall be as follows:

- 50% - Smoky Lake County
- 25% - Town of Smoky Lake
- 12.5% - Village of Vilna
- 12.5% - Village of Waskatenau

The above noted formula shall be known as the Trider Formula.

**7. REPEAL**

Bylaw No. 829-89 Smoky Lake Regional Economic Development Committee be repealed.

**8. EFFECTIVE DATE**

This Bylaw shall come into force and effect on the final date of passing thereof.

READ a Third and Final Time this 19 day of June, AD 2008 and finally passed by Council.
