| Policy Statement and Guidelines: |
| <p>1. CONTRAVENTIONS: PROCEDURES</p> <p>1.1 Water Plant Operators are required to contact Alberta Environment immediately upon discovering any contraventions to Water Drinking Guidelines.</p> <p>1.2 After contacting Alberta Environment, the operator will contact the Water/ Wastewater Manager. The Manager will in turn notify the Smoky Lake County Chief Administrative Officer and Council of any incident.</p> <p>1.3 The Water and Wastewater Manager will contact Alberta Environment to confirm that the incident has been reported, evaluate the situation and develop an appropriate course of action to correct the contraventions and protect the quality of drinking water.</p> <p>2. RESPONSIBILITIES</p> <p>2.1 The Water/Wastewater Manager: maintains <u>direct responsibility</u> control having a Level (2) Water Treatment Certification. The Manager supervises the operations of the Smoky Lake County’s Water Treatment and Distribution System: supervises crews engaged in maintenance, construction, and repair activities; carries out testing to ensure all work and work procedures follow municipal and provincial construction and safety standards and performance in their related duties.</p> |
