County Council – January 28, 2021: Motion

That Smoky Lake County in partnership with the Town of Smoky Lake, Village of Waskatenau, and the Village of Vilna participate in the application of the 2020-2021 Alberta Community Partnership (ACP) Grant for the Project Titled: Regional Fire Services under the "Intermunicipal Collaboration Framework" Component Grant for the total project cost in the amount of \$200,000.00; and approve Smoky Lake County to be the Managing Partner under the said application; and further agree to abide by the terms of the Conditional Grant Agreement governing the purpose and use of the grant funds.

- Smoky Lake County Administration and Fire Protective Services personnel met with Transitional Solutions Inc in June to implement the 3 phase project (Governance, Fire Service Operations and Master Plan) outlining the timeframe from Governance, Fire Service Operations and Master Plan.
- The first components for Phase 1 and 2 of the project involved interviewing all the fire chiefs, CAO's and Councils, completing surveys and compiling information on current operations, all legislative documents and financials for a timeframe of 3 years.
- Phase 2 Governance interim report was completed and sent to the Smoky Lake County on September 17, 2021.



Why are we pursuing visitor economy developments?





From County Public Budget Presentation:

New Revenue Source

In the Strategic Plan for 2018 - 2020 Council identified the need to find new sources or revenue. This conversation led to the development of the **Victoria District Economic** Development Plan.

- Through Economic Development, the County will:

 Arrest the declining population which will help maintain and expand core services

 Improve property values

 Reduce unemployment and underemployment

 Create career opportunities for youth

 Retain residents

 Retain, expand, and attract businesses

 Distribute wealth to equalize services, infrastructure and opportunities

The Victoria District Economic Development Corporation will improve the Counties financial outlook by:

Yeroviding dividend revenues

Increased non residential assessment will be a result of new businesses. For example the assessment for Metis Crossing has increased from \$415,000 to \$5,115,270 over the past four years providing the County with over \$150,000 to tax revenue

Profit Distribution (from Business Plan)

Corporate net profits are distributed annually:

- 40% paid as dividends to the Corporate partners: Town of Smoky Lake, Smoky
- Lake County and Métis Nation of Alberta.
 25% to community fund for heritage and social projects.
- 25% reinvested for business loans.
- 10% retained as reserves.

The aim will be to make the Tourism Corporation cash neutral by 2024, be making profit, and paying a dividend to all shareholders from 2025 onwards.

Anticipated 10 -year returns of \$10MM distributed to Foundation shareholders (MCC and MNA).

These profits are in addition to any increased assessment collected by the Municipalities on the new/expanded developments.

Current Projects:

At least 5 new developers in the Region with an investment value of \$20 -30 m, which includes a 400 capacity RV and Leisure Attraction, a Wellness Spa, glamping and cabins, and an Adventure Attraction featuring zip lines, Luge track, and tree

These projects will be open for resident use as well as visitors.



By 2023, we would expect to be running a county-wide booking system for activities and accommodation bookings and the income will significantly increase.

These projects will include:

- Horse riding tours (Bellis Area)
 Farm Store expansions
 ATV and Snowmobile hire and Tours (Vilna)
- · E-bike and Bike Hire and Tours
- Fishing Tours
 Expand existing festivals
- A new winter or spring -based Country food Festival
 2-3 other seasonal events
- Activities at Northern Lights Resort
 Further activities at Métis Crossing
- Activities at Waskatenau (new heritage and wildlife property by private developer)
 10 Star Watching Pods at Métis Crossing
 Tourism Corporation opens its first hotels and B&B's

- · Many more private operators running wildlife, cooking and cultural experiences





- The projects commencing in 2024 will include:

 The Opening of the Smoky Ring

 The Opening of the Adventure Attraction near Smoky Lake

 Relaunch of Smoky Lake Museum (this could be 2025)

 Northern Lights RV Resort

- · Northern Lights Family Adventure Centre to open
- More activities and accommodation at Métis Crossing
 Many more small operators running accommodation and tours
- · 2-3 new seasonal county events

The business aims to grow the Smoky Lake tourism economy from \$7 -8 million to \$60+ million in ten years, creating 600 new jobs and increasing Regional population from 4200 to 4700 +. The Regional visitation targets for year 10 are 1200+ units of accommodation including hotel, bed and breakfast, self -catering, camping, premium RV and Lodges, and 125,000 travellers spending \$200 -\$300 per day and staying 3+ nights. In addition, the forecasts show the Region attracts 170,000 day trippers spending \$40-\$60 per day.

Municipally Controlled **Corporation Summary**

EXECUTIVE SUMMARY

Two municipal partners, Smoky Lake County and the Town of Smoky Lake, are to be joint partners in a municipally controlled corporation (MCC), contributing \$600K each through loans and share purchasing.

The MCC provides a corporate platform for the Town and County to be able to put money into the local tourist economy and provide a legal and financial buffer for the municipalities, from any operational or financial liabilities.

The MCC ensures economic diversification in the Region through lending to and investing in, the Smoky Lake Tourism Corporation. The MCC is not intended to be a profitable entity but a Regional economic diversification vehicle.

MCC Ownership

50% Town of Smoky Lake 50% Smoky Lake County

GovernanceBoard with two members each from Town and County. Rolling Chair of MCC elected by Board Members

Funding \$10,000 share purchase by Town \$10,000 share purchase by County \$590,000 loaned from Town of Smoky Lake \$590,000 loaned from Smoky Lake County

Operational IncomeDividends, interest and fees from investments in Smoky Lake Tourism Company.

MCC Activities

- Report MCC activities to Municipalities
 File SLTC Director Reports to SLTC Board
 Nominates Board members for the Smoky Lake Tourism Company (SLTC)*
 Channel municipally sourced grants, loans and investments to SLTC
 Pay loan payments from SLTC to Municipalities

- Minimize operating costs to Board meetings (1 per year), special meetings if required, legal and financial filing costs as required by Alberta Corporate regulations.

*Board members nominated to SLTC do not need to be MCC Board members; the MCC may nominate Directors to SLTC with the skills and experience to drive the activities of the SLTC



- Employ staff
- Rent offices
- Pay MCC Directors
- Invest or loan to other projects or companies
- Get involved in SLTC daily operations or report to Municipalities on SLTC activities except for loan repayments/status.












