Notice Of Proposed Material Change to Smoky Lake Development Corp The Public Hearing was called to order at 10:01 a.m. by the Reeve, Jered Serben, in the physical presence of all Council members, with Linda Fenerty being absent, Chief Administrative Officer, Municipal Clerk, Finance Manager, and Planning and Development Manager with 10 Members of the Public online, as well as 6 other County Staff.

> The purpose of the hearing was summarized: Today's Public Hearing has been called to gather public input on a proposed material change to the operations of the Smoky Lake Development Corporation.

> Specifically, Smoky Lake County Council is considering the suspension of the current tourism development service within the municipal boundaries. This suspension would remain in effect until viable future economic opportunities are determined.

This Public Hearing provides an opportunity for residents to express whether they believe this proposed change is in the best interests of the municipality and its residents. Anyone wishing to speak today must have registered in advance, and we will hear from those who have submitted written notice accordingly. We thank you for your participation and input on this important matter.

Smoky Lake County field day will be on July 24 this year and LARA will also have a booth at Smoky Lake County Farmer appreciation BBQ on June 13, next meeting June 23 @ 9am in Ashmont.

- Smoky Lake Regional Heritage Board we are planning for the official opening of the Ruthenia School with suggestion that it be on Heritage Weekend in August. Proposal made to have bus tours after the formal program to tour Ruthenia School and other heritage spots. Length of tour would be about 3 hours. Motion made to rental bus/buses \$2,500.00 Discussion held on purchasing a kiosk (interactive) for locations, i.e. Vilna, Waskatenau, Town of Smoky Lake. Possible we will start with a pilot project at the Train Station. Cost of kiosk is approximately \$3,000.00. Another idea bandied about was to purchase a Smart TV to display information about the history of the Train Station, approx. \$500.00. Motion made to spend up to \$3,500.00 for both kiosk and TV. May 19, the Heritage Board will visit the

•Program is a 4 stage program: Stage 1 is stabilization; Stage 2 is Primary treatment; Stage is Therapy; and Stage 4 is Transitional

•No cell phones allowed in Stages 1 and 2 (unless there are exceptional circumstances)

•Stage 2 consists of primary treatment and may last from 60 to 120 days

•Stage 3 includes therapy, lectures, residents working in the building (maintenance, cooking, cleaning, to list a few). Residents are taught work force skills and cell phones are allowed only during the day. For example, the kitchen is a training kitchen. Residents are able to not only do dishes but also prepare the meals. Leadership positions are positions which residents need to apply and interview for. Leaders are rewarded with a single room otherwise residents share rooms.

•Stage 4 is transitional. At this point, plans are made to ensure that the residents have everything in place, safe housing for when they leave, finances in place, a job to go to and so forth. They now have their cell phones.

•The GOAL is to be able to function in society and be self sustained.

•The men and women are kept separate for the majority of the time. There is some crossover but very little. For example, free time and meals are

gender specific.

•Group and clinical counselling is available to all, the setting is such that it is based on a community model where residents can help each other.

•There is an electronic board which indicates what is going on when. There are set times for exercise, meals, smudge, specific meetings (AA, Mindfulness meditation, group therapy for example).

•There is a medication window and a nurse is on staff 24/7. Addiction specialists are on call.

•Residents set smart goals weekly. Individualized programs where residents do have a say.

•Visitors are allowed on Sundays but this is not for Stage 1 residents. Families are allowed to show up for "Cake Night"; this is when individuals are honored for their 30-60-90 day completions.

•Stage 3 and 4 residents do get day passes but if they are gone for any extended period of time, they do get screened upon return to the centre.

•There are numerous Rehabilitation Providers which operate differently. EHN (this facility's provider), seems to offer quite a bit of counselling. They have a national center therefore draw from all over Canada. Fresh Start is another Rehabilitation Provider.

That Smoky Lake County schedule a Regional Emergency Management Agency (REMA) meeting on September 10, 2025, to be immediately followed by a Hazard, Risk, and Vulnerability Assessment (HRVA) session facilitated by the Alberta Emergency Management Agency (AEMA).

Motion #2

That Smoky Lake County schedule a Regional Emergency Management Committee (REM Committee) meeting to take place in conjunction with the next Joint Municipalities Meeting.

Background:

As mandated by Bylaw No. 1466-24: Regional Emergency Management, sections 4.7 and 5.8, Smoky Lake County is required to convene both the Regional Emergency Management Committee and the Regional Emergency Management Agency at least once annually. These meetings ensure that the County and the Region remain compliant with the municipal bylaw and provincial expectations for emergency preparedness.

In addition, the Local Authority Emergency Management Regulation, Section 4(d), requires all municipalities in Alberta to conduct a Hazard Identification and Risk Assessment (HIRA) to inform and support their Municipal Emergency Management Plan. This is a legislated requirement and must be reviewed and updated on an annual basis.

To meet these obligations, Smoky Lake County should host the REMA meeting and then facilitate a collaborative stakeholder session to complete the HRVA This will support legal compliance, encourage regional collaboration, and ensure the Emergency Management Plan reflects current risks and vulnerabilities facing the community.

Benefits: Hosting the REMA meeting and completing the HRVA ensures compliance with the municipal bylaw and provincial legislation. It enhances intermunicipal coordination and emergency preparedness across the region. The HRVA allows for the identification and mitigation of local risks, ultimately strengthening our emergency response capabilities. Completion of these requirements also positions the county to remain eligible for provincial or federal emergency management funding in the event of an emergency. Proactive planning helps to reduce operational costs and resource strain during real emergencies by ensuring employees are properly trained and response plans are up to date.



Disadvantages: There may be minor scheduling challenges and time commitments required from regional stakeholders. Additionally, staff time will be temporarily redirected to meeting coordination and facilitation, followed by updating the Regional Emergency Plan accordingly.

Alternatives: An alternative would be to ask another regional partner to host and facilitate the meeting. However, this would remove the County's opportunity to lead and could delay progress on the HRVA. Another alternative would be to postpone the meeting, which may result in further non-compliance with legislation and an increased risk of being unprepared in the event of an emergency.

Financial Implications: There will be minimal costs associated with hosting the REMA and HIRA meetings, including expenses for a meeting venue, light refreshments, a lunch, and printed materials. However, if the HIRA is not completed and an emergency occurs, the County may become ineligible for certain funding opportunities. Completing the HIRA and maintaining an updated emergency plan can also result in long-term savings through efficient resource deployment and reduced emergency-related staffing costs.

Legislation: This request is supported by Bylaw No. 1466-24: Regional Emergency Management and the Local Authority Emergency Management Regulation (Alta. Reg. 203/2018). Section 4(d) of the Regulation specifically requires that each municipality conduct a hazard and risk assessment to inform their emergency management plan.

Intergovernmental: This initiative involves coordination with the Town of Smoky Lake, the Village of Vilna, the Village of Waskatenau, and the Alberta Emergency Management Agency (AEMA).

BEING A **REVISED** BYLAW OF SMOKY LAKE COUNTY IN THE PROVINCE OF ALBERTA TO AUTHORIZE LENDING MONEY TO A MUNICIPAL CONTROLLED NON-PROFIT ORGANIZATION

WHEREAS pursuant to Sections 264 and 265 of the Municipal Government Act, R.S.A. 2000, Chapter M-26 and amendments thereto, a municipality may loan funds to a non-profit organization or one of its controlled corporations

AND WHEREAS, the MCC for Smoky Lake Development Corp is a non-profit municipal controlled corporation duly incorporated under the laws of the Province of Alberta.

AND WHEREAS, the MCC for Smoky Lake Development Corp; is owned 50% by Smoky Lake County and 50% by the Town of Smoky Lake.

AND WHEREAS, the MCC for Smoky Lake Development Corp will invest in the Smoky Lake Tourism Company Ltd which will invest and or lend funds for local tourism opportunities.

AND WHEREAS, the County of Smoky Lake's available debt limit established by the provisions of 276(2) of the Municipal Government Act, R.S.A. 2000, Chapter M-26 was \$23,249,337

NOW THEREFORE, be it resolved that the Council of Smoky Lake County in the Province of Alberta, duly assembled hereby enacts as follows:

- 1. Smoky Lake County will lend to the MCC for Smoky Lake Development Corp the amount of Five Hundred Ninety Thousand Dollars (\$590,000) for the purpose of investing in the Smoky Lake Tourism Company Ltd. The term of the loan is eight (8) years.
- 2. The interest rate offered is 6.5% (per annum), and is based on the MCC for Smoky Lake Development Corp business plan.
- 3. The loan will be repaid by the MCC for Smoky Lake Development Corp annually on or before December 31 of each year, beginning December 31, 2024 hereafter called the "due date". The loan will be repaid according to the schedule outlined in Schedule "A", attached hereto forming part of this bylaw
- 4. Payments may be made without penalty in advance of the due dates above. Payments in advance of the due date will result in the recalculation of future payments. Interest is due or payable on the outstanding balance at the time of each repayment installment.
- 5. It is anticipated that the MCC for Smoky Lake Development Corp will repay the loan from investment earning.

Revised Bylaw No. 1413-22

- 6. The source of money to be loaned to the MCC for Smoky Lake Development Corp shall be from the General Capital Reserve Fund held by Smoky Lake County. All principal repayments received from the MCC for Smoky Lake Development Corp shall be returned to this reserve. All interest earned shall be allocated to general revenue in the year it is received.
- 7. **Revised to:** The MCC for Smoky Lake Development Corp shall provide Smoky Lake County with an executed Promissory Note and General Security agreement consistent with the terms of this bylaw.
- 8. Any funds not used by the MCC for Smoky Lake Development Corp for the purposes contained in this bylaw or the funding agreement shall be immediately returned to Smoky Lake County.
- 9. This bylaw shall take effect on the day of the final passing thereof and shall remain in effect until all amounts due to Smoky Lake County specified within this bylaw have been received.

two separate applications. These motions were related to projects on lands legally described as NW-12-58-14-W4 and SW-1-60-14-W4, submitted by Brad Shapka and Brad Veno, respectively.

Upon review, it was identified that the maximum funding amounts stated in the approved motions were inadvertently reversed. Motion 335-25 incorrectly stated a maximum funding amount of \$2,500.00 for Brad Shapka's application, which should have been \$5,000.00. Conversely, Motion 336-25 incorrectly stated a maximum funding amount of \$5,000.00 for Brad Veno's application, which should have been \$2,500.00.

As these discrepancies conflict with the intended funding levels and County Policy Statement No. 03-21-06, Council is required to formally rescind the incorrect motions and pass new resolutions reflecting the correct amounts. The corrected motions are presented for Council's consideration and approval to ensure program integrity and alignment with policy

Benefits: Continued recognition of Smoky Lake County's support for local landowners participating in land improvement initiatives, reinforcing the County's commitment to sustainable land use practices and alignment with County Policy Statement No. 03-21-06.

Background:

Smoky Lake County Council requested a 2025 Open House for the community to view and learn about County services, equipment, and programs. This location would allow all departments to display their equipment and for operators and managers to be available to explain their roles and responsibilities.

However, this option raises several concerns:

- Public liability risks associated with visitors entering an active County works yard.
- The logistics of bringing every piece of equipment to town for the day.
- Potential theft or damage of equipment and tools.
- Proximity to a neighbour engaged in a lawsuit against the County, which may pose reputational or legal complications.
- The selected date falls on the Friday before a long weekend, potentially reducing public and staff availability.





Topic: Policy 15-07-01 Employee Participation in Municipal Election Campaigns

Presented By: Kevin Lucas, CAO

Recommendation(s):

That Smoky Lake County Council approve Policy HR-07-01 titled "Employee Participation in Municipal Election Campaigns" as presented, to ensure compliance with the Municipal Government Act and the Local Authorities Election Act, and to safeguard administrative neutrality and the integrity of municipal operations.

Background: The proposed Policy HR-07-01 is designed to establish clear rules for County employees participating in municipal election campaigns. It ensures legal compliance with relevant legislation while maintaining the political neutrality of County administration. This policy is especially pertinent during general and by-election periods and is intended to clarify expectations and procedures regarding campaigning and running for office by County employees.

Benefits: Ensures compliance with Sections 174, 207, and 153 of the Municipal Government Act and Sections 5, 22, 23, and 147.2(1) of the Local Authorities Election Act. Protects the impartiality and neutrality of the County's operations. Clarifies procedures for employees seeking election, including campaigning rules, required leaves of absence, and resignation protocols. Enhances public trust in municipal governance by preventing conflicts of interest.

Disadvantages: May require employee awareness training during election years. Potential temporary staffing gaps during employee leaves of absence.

Alternatives: There are no alternatives to the recommendation because it is a legislative requirement.

Financial Implications: There are no financial of budget implications to this recommendation.

LEGISLATIVE REFERENCE:

In accordance with the following Sections of the Municipal Government Act:

Section 174 – Disqualification of Councillors: Specifies that a municipal employee is disqualified from becoming or remaining a councillor of the same municipality where they are employed.

Section 207 – CAO Responsibilities – Administrative Neutrality: Reinforces that the administration must be politically neutral and act impartially in carrying out duties.

Section 153 – General Duties of Councillors: Emphasizes that elected officials must avoid conflicts of interest and maintain the public trust.

And in accordance with the following Sections of the Local Authorities Election Act:

Section5 – A person who is an employee of a municipality and who wishes to be nominated as a candidate in an election to be held for that municipality may notify that person's employer on or after January 1 in the year of a general election or on or after the day the council passes a resolution to hold a by-election but before the person's last working day prior to nomination day that the person is taking a leave of absence without pay under this section.

Section 22(1) – Ineligibility to be nominated: States that a person is not eligible to be nominated as a councillor if they are an employee of the municipality on nomination day unless they take a leave of absence.

Section 23 – Leave of Absence for Employees: Mandates that employees of a municipality must take a leave of absence without pay upon filing nomination papers and that they must resign if elected.

Section 147.2(1) – Prohibited Use of Resources: Prohibits the use of municipal resources to support a candidate's election campaign.

PURPOSE:

To provide guidelines for employee participation in municipal election campaigns that ensure compliance with the *Municipal Government Act* and the *Local Authorities Election Act*, while protecting the neutrality and integrity of Smoky Lake County's operations.

STATEMENT:

Smoky Lake County recognizes that employees are entitled to participate in the democratic process, including supporting or seeking elected office. However, participation must not interfere with job duties, compromise the impartiality of the municipality, or result in a conflict of interest. This policy outlines expectations and procedures to maintain administrative neutrality and legal compliance during election periods.

OBJECTIVE:

To establish clear rules for County employees regarding participation in municipal election campaigns, including when campaigning is permitted, the use of County resources, and procedures for leave of absence if an employee intends to run for elected office.



GUIDELINES & PROCEDURE: 1. Campaigning by Employees

1.1. Employees may engage in election campaigning only outside of scheduled work hours and off County property.

1.2. No campaigning is permitted on County-owned lands, buildings, vehicles, or worksites during business hours or during the employee's paid work time.

1.3. County resources—including but not limited to photocopiers, telephones, computers, logos, vehicles, and emails—shall not be used for any election-related purpose.

1.4. Employees must not wear apparel with the County Logo or represent themselves as County staff while engaging in campaign activities.

2. Leave of Absence for Employees Seeking Nomination

2.1. In accordance with Section 22(1) and Section 23 of the Local Authorities Election Act, any employee of Smoky Lake County who files a Notice of Intent or Nomination Papers to run for office must take a leave of absence without pay effective the day such papers are filed.

2.2. The employee may choose to use accrued vacation time or banked time in lieu of an unpaid leave.

2.3. If the employee is not elected, they may return to their position on the next scheduled workday following confirmation of election results.

2.4. If the employee is elected to Smoky Lake County Council, they must resign their position with the County effective the day they assume office, as per *Section 174 of the Municipal Government Act*.

2.5. If the employee is elected to another municipality's council, the *Chief Administrative Officer (CAO)* will assess potential conflicts of interest and determine whether continued employment is permissible.

3. Conflict of Interest and Political Neutrality

3.1. Employees must avoid actions or statements that may compromise the political neutrality of the County administration (see Section 207 of the MGA).

3.2. Employees must refrain from using their position or access to County information to support or oppose any candidate, in alignment with *Section 147.2(1)* of the Local Authorities Election Act.

4. Reporting and Enforcement

4.1. Any concerns or suspected violations of this policy must be reported to the CAO or Human Resources.

4.2. Breaches of this policy may result in disciplinary action, up to and including termination, as per the County's personnel policies.



Background: Smoky Lake County received a letter from the landowner of tax roll 18601410 on May 22, 2025 regarding waiving the natural gas charges applied to the tax roll from Smoky Lake County Natural Gas Account #60110.01 on March 23, 2024, and shown on the landowners 2024 Tax Notice. The natural gas charges that were transferred to the tax roll consisted only of accumulated unpaid monthly service charges from April 1, 2021 to February 29, 2024. Prior to this, Smoky Lake County Natural Gas transferred \$3,011.95 to the tax roll for unpaid natural gas consumption and service charges for the period of May 1, 2016 to March 31, 2021.

The landowner stated during a phone conversation in October 2024 with myself, that in 2015, he spoke to the natural gas manager at the time and requested the natural gas service be removed. I was unaware of this and the charges continued. The account was released by the landowner in October 2024, when he requested the account terminated. The gas meter was removed and the service line to the property was abandoned in October 2024, upon signing of the release of service contract.

Benefits: Collect unpaid natural gas charges transferred to tax roll in 2024, which remain unpaid in 2025.

Recommendation:

That Smoky Lake County Council approve the following motions:

Motion #1 -To amend the 2025 Natural Gas capital budget by changing the vehicle replacement of Unit 208 from year 2026 to year 2025 with a budget of \$28,000; and the vehicle replacement of Unit 232 from year 2025 to 2026 with a budget of \$40,000.

Motion #2 - to approve the purchase of the 2011 Dodge 5500 ex-odorant truck (Unit 214) from Alberta Odorant Services for the price of \$19,000 plus GST, for the replacement of Unit 208 2008 Chev 5500, and sell Unit 208 at auction or transfer to another department.

Background: With Alberta Odorant Services purchasing a new truck for the Smoky Lake Odorant Delivery body, the 2011 Dodge 5500 4x4 diesel (Unit 214) has been offered to the Natural Gas department for purchase for \$19,000 plus GST, prior to listing the truck for sale to other Federation members or sending it to an auction. Smoky Lake County has operated, serviced, and maintained this truck since it was new. It currently has approx. 280,000 kms, is in above average condition, and would make an ideal candidate to install a new flat deck on (as it is currently a cab & chassis with the odorant body removed) and to replace Unit 208 2008 Chev 5500 4x4 diesel that has approx. 160,000 MILES (US truck). Unit 208 has an overheating issue, history of electrical issues, as well as brake parts are becoming harder to source. Unit 208 currently is used to pull Unit 233 32 foot tandem dually trailer and mainly hauls Unit 209 Ditch Witch trencher.

Benefits: 2011 Dodge 5500 can be purchased below market value, based on past auction results on similar trucks. Unit 208 can either be sold or transferred to another department who requires it, if there is another departments interested in it.

Disadvantages:

Alternatives: Not purchase the 2011 Dodge 5500 and replace next year, as scheduled with auction purchase.

Financial Implications: The 2011 Dodge would require the purchase and installation of a flat deck with gooseneck trailer hitch for pulling Unit 233 trailer. The total cost for the truck and flat deck would be \$28,000.00

This would change the 2025 capital budget by:

Removing the replacement of unit 232 at a cost of \$40,0000 funded from reserve and including the \$40,000 it in the 2026 capital budget

Adding the replacement of unit 208 at a cost of \$28,000 funded from reserve and removing \$50,000 from the 2027 capital budget

Background:

Smoky Lake County Council tasked administration with conducting a jurisdictional scan of other municipalities to determine how recreational vehicles are permitted on residential properties. Currently, Smoky Lake County Bylaw 1432-23 allows for the year round placement of up to two (2) RVs in hamlet and country-residential areas, with additional RVs being permitted for up to a maximum of four (4) consecutive days. These additional RVs must be removed from the property for a minimum of 24 hours before a subsequent 4-day period can be renewed. Bylaw 1432-23 does not apply to agricultural lands. Bylaw 1432-23 also prohibits RVs from being permanently connected to any utility or municipal service.

Regional Employer Supports

Employer Resources 2025

The following list of resources is not exhaustive and is updated on an ongoing basis. Note that funding opportunities may have application windows.

Grants and Funding Programs – General

<u>Indigenous Employment Training Partnerships Program (Government of Alberta)</u> – grant funding for Indigenous communities and organizations to deliver group-training projects designed in partnership with employers and other partners.

<u>Northern and Regional Economic Development Program (NRED) (Government of Alberta)</u> – funds initiatives led by Alberta municipalities, Indigenous communities, and non-profits that promote regional economic development and diversification.

<u>Wage subsidies and assistance programs (Government of Canada)</u> – information on federal programs to help you hire the right employees for your business.

<u>Training on the Job Program (WCB Alberta)</u> – subsidy to employers to hire and train someone who is unable to return to their regular job due to a workplace injury. The worker develops skills and gains work experience while the employer receives financial support from WCB during the employee's training period.

<u>Workforce Partnership Grant (Government of Alberta)</u> – grant program to support labour market adjustment strategies and workforce development through partnerships. The program includes Labour Market Partnerships and Workforce Attraction and Retention Partnership projects.

<u>Workforce Strategies Grant (Government of Alberta)</u> – grants to support organizations with innovative solutions that will help Albertans develop new skills and assist employers and industry to grow their workforce.

<u>Workplace Training Program (Government of Alberta)</u> – offers eligible Albertans work-site training and paid work experience. Participating employers provide on-the-job training and/or work experience with government funding contributions, with the expectation that participants maintain employment after completion of the program.

<u>Ukrainian Rural Alberta Attraction Program</u> – **Are you struggling to get employees?** This is a new provincial funded program lead by Alberta Association of Immigrant Serving Agencies (AAISA) to match Ukrainian nationals with employers in rural Alberta.

<u>Work-Sharing Program (Government of Canada)</u> – The Work-Sharing Program helps employers and employees avoid layoffs when there is a temporary decrease in the normal level of business activity, beyond the control of the employer.

Grants and Funding Programs – Industry-Specific

<u>Addressing the Agriculture Labour Task Force Grant Program</u> – funding to increase public awareness of agricultural career opportunities and to provide human resources training to support worker retention.

<u>Food Futures Program (Alberta Food Processors Association)</u> – wage subsidies of 50% (to maximum of \$5,000) are available to hire current post-secondary students and recent grads (within six months) for temporary work experience placements (minimum 200 hours). Placements can be in any area relevant to the industry, including nutrition and food science, agriculture, technologists, accounting and finance, human resources, IT, logistics, safety, engineering, business, etc.

<u>Training & Wage Subsidies for Environmental Jobs (ECO Canada)</u> – employment programs that stimulate environmental career pathways, skill development, business growth, workforce support and workforce advancement through wage and training funding.

<u>Class 1 Learning Pathway Grant Program | Alberta.ca</u> - The grant program consists of two streams: the Employment Pathway Grant and the Industry Advancement Grant. The Employment Pathway Grant supports the training and employment of Class 1 drivers by reimbursing employers for onboarding, training, and certain professional development costs. The Industry Advancement Grant focuses on building capacity within the commercial transportation industry to address challenges related to employment, attraction, retention, and diversification of Class 1 drivers.

Grants and Funding Programs – Youth and Apprenticeships

Apprenticeship job creation tax credit - offers a non-refundable tax credit an employer can claim for each eligible apprentice.

Apprenticeship - funding opportunities for skilled trades and apprenticeship - Canada.ca

<u>Canada Summer Jobs wage subsidy (Government of Canada)</u> – wage subsidies to employers with 50 or fewer full-time employees to create quality summer work experiences for young people aged 15 to 30 years. Deadline to apply is December 19, 2024.









Alberta restaurant sales increased by 5.3% in March 2025 compared to March 2024, to \$1.1B. Saskatchewan had the largest increase (8.1%) in restaurant sales year-over-year, among Canadian provinces. Nationally, restaurant sales increased by 6.0% over the same time frame.

exports through international travel to formal outbound trade events. Changes were made to reduce red tape, improve consistency, and clarify program criteria. The revised program is now <u>live</u> and open for applications for travel taking place after April 1, 2024.

Key changes made to make the program more user friendly include:

- only one application post-travel is required, there is no longer a pre-approval review process;
- reimbursement is now based on per diems and base fee event registration costs; and
- digital signature and electronic payment processes are built in to increase efficiency.

Other changes to the program include:

- a maximum amount of CAD \$15,000 per organization per funding year;
- requiring attendance at a formal international trade event, such as conferences, trade shows and conventions;
- raising the minimum gross annual sales requirement for eligibility from CAD \$50,000 to CAD \$250,000 to better focus support for export-ready companies; and
- only providing funding for outbound missions.

Although you will no longer need pre-approval, you are encouraged to complete the self-assessment survey, which can be found on the website, to gauge your eligibility. For more information, please take a look at the new program guidelines and fact sheet.

Economic Development Funding Resources May 2025

The following list of resources is not exhaustive and is updated on an ongoing basis. Note that funding opportunities may have application windows that have changed or are not listed in this document. This document is to be considered a snapshot in time. "NEW" simply indicates a program being added to this document since the last update.

Funding Programs (Continuous)

Aboriginal Entrepreneurship Program (AEP)

Intake: Open

Access to capital and access to business opportunities for Indigenous entrepreneurs and business owners in Canada.

AllC Grant for Status Entrepreneurs

Intake: Open

This program provides equity assistance for the start-up or the expansion of small businesses for Status individuals.

NEW Blue Cross Community Funding

Intake: Closes April 30 50, \$1,000 awards to support health and wellbeing in communities

NEW Alberta Food Matters

Intake: Various Various food-related grants for community-led projects

Alberta Food Processors Association - Food Futures

Intake: Closes Sept 30, 2025

The Alberta Food Processors Association (AFPA) has received funding from the Alberta Government to support Work Integrated Learning placements in the food processing industry. This funding will support up to 90 student placements per year for the next 3 years. Wage subsidies of 50% (maximum subsidy \$5,000) are available to hire current post-secondary students and recent grads (within 6 months) for temporary work experience placements (minimum 200 hours), which can take place at any time during the year.

Alberta Indigenous Opportunities Corporation

Intake: Ongoing

With up to \$1 billion in loan guarantees available, we enable access to capital, make financing more affordable and improve lending terms to create economic prosperity and social improvements in communities – not only for the short term but also for generations to come.

Alberta Innovates Funding Programs

Intake: Varies

Alberta Innovates provides a number of funding programs to support research, the growth of business, and help the start-up community to build new technology and drive new ideas.

Alberta Real Estate Foundation

Intake: Varies

Alberta Real Estate Foundation funds initiatives that support and advance education, research, law reform, and other activities related to real estate across our three Funding Priorities of Real Estate Leadership, Built Environment, and Land.

Apeetpgpsan Metis Entrepreneurs' Assistance (MEAP) Grant Program

Intake: Open

This program provides equity assistance for the start-up or the expansion of small businesses. The grant is for Métis, Inuit, or Non-Status individuals and is named The Métis Entrepreneurs' Assistance Program (MEAP).

Canada Food Innovation Network

Intake: Varies

CFIN is open to organizations across Canada's food ecosystem. Join more than 1500 members, including manufacturers, processors, distributors, retailers, funders, and innovators.

Canada Revenue Agency (CRA) - Scientific Research and Experimental Development (SR&ED) Tax Incentives

Intake: Open

The Scientific Research and Experimental Development (SR&ED) Program uses tax incentives to encourage Canadian businesses of all sizes and in all sectors to conduct research and development (R&D) in Canada. These tax incentives come in three forms: an income tax deduction, an investment tax credit (ITC), and, in certain circumstances, a refund.

Canada Mortgage and Housing Corporation (CMHC) Funding Programs

Intake: Varies

Canada Mortgage and Housing Corporation (CMHC) is Canada's national housing agency. Explore options though the National Housing Strategy and other CMHC programs that are designed to build or renovate affordable housing. This includes initiatives for Indigenous communities. Funding is also available for housing innovation and research.

• **NEW Affordable Housing Innovation Fund: Open** - Support for new ideas that will drive change and disrupt the industry.

Co-op Community Spaces Fund

Intake: Closed

Community Spaces was developed to support projects in the communities across Western Canada in which we live, work and operate. Projects can apply for between \$25,000 and \$150,000 in capital funding in three categories: recreation, environmental conservation, and urban agriculture.

Eco Canada - Wage Funding Eco Employment Programs

Intake: Varies

Employment programs that stimulate environmental career pathways, skill development, career growth, workforce support, and workforce advancement through wage and training funding.

Emissions Reduction Alberta

Intake: Varies

ERA is investing in a diverse portfolio of transformative, sustainable technologies that reduce GHG emissions and position Alberta for success in a lower emissions economy.

Enbridge-Safe Community First Responder Program

Intake: Open

The program awards grants for safety equipment, professional training, or safety education programs to emergency response organizations including fire departments, emergency medical and rescue services, emergency management organizations, 9-1-1 centers, ambulance services and law enforcement organizations.

NEW FCC AgriSpirit Fund

Intake: Open June 25, Closes July 30 Capital funding for rural communities under 150K population

Government of Alberta- Aboriginal Business Investment Fund Intake: Closed

The Aboriginal Business Investment Fund (ABIF) can partially or completely fund capital costs for Indigenous community-owned economic development projects. Projects like these improve social and economic outcomes for Indigenous Peoples and their communities.

Government of Alberta- Active Communities Initiative

Intake: Closes June 30, 2025

The Active Communities Initiative is open to eligible community groups, non-profit organizations, and societies, and First Nations and Métis Settlements, that wish to build or enhance active spaces that support sport and recreation in their communities. The grant is intended for small and mid-sized projects, including indoor and outdoor skating rinks, community pools, indoor turf centers, pickle ball courts, sports fields and courts, and other sport and recreational facilities.

Government of Alberta – Affordable Housing Partnership Program

Intake: Closed

Public, non-profit, and private-sector housing providers can apply for funding for innovative and sustainable affordable housing projects.

Government of Alberta - Agricultural Societies Program (Infrastructure Revitalization)

Intake: Expected spring 2025

The Agricultural Societies Infrastructure Revitalization Program provides annual capital funding to help agricultural societies make major repairs to existing infrastructure. This is a new program.

Government of Alberta- Alberta Broadband Fund

Intake: Stream 3 is expected in 2025

This stream will support the most remote and hardest to connect households that will not benefit from other broadband expansion projects. A limited number of remote households will be eligible to apply for a one-time grant to off-set the cost of adopting high-speed internet.

Government of Alberta - Alberta Export and Expansion Program

Intake: Open

Funding to help export-ready companies and non-profit organizations enhance access to international markets and attract global buyers.

Government of Alberta - Alberta Media Fund

Intake: Varies

The Alberta Media Fund (AMF) offers a variety of grants to help support the growth, sustainability, competitiveness and business attraction of our province's cultural industries.

Government of Alberta - Alberta Agri-Processing Investment Tax Credit

Intake: Open

The Agri-Processing Investment Tax Credit (APITC) provides a 12% non-refundable tax credit against eligible capital expenditures for corporations investing \$10 million or more to build or expand Agri-Processing facilities in Alberta.

Government of Alberta - Alberta Community Partnership (ACP)

Intake: Varies

Projects that directly support new or enhanced regional approaches to municipal ser vice delivery are eligible under the IC component. Provincial priorities **include investment attraction**, **job creation**, efficient public service delivery, and emergency management and disaster mitigation. As such, regional partners may choose to explore regional development and planning, shared service delivery, **economic development and growth**, emergency preparedness and planning, emergency response, disaster mitigation, or other related projects.

Government of Alberta- Alberta Municipal Water/wastewater Partnership

Intake: Open until November 30 for funding in the following year.

The Alberta Municipal Water/Wastewater Partnership (AMWWP), which launched in 1991, provides costshared funding to eligible municipalities to help build municipal facilities for water supply and treatment, and wastewater treatment and disposal.

Government of Alberta - Art, Culture, and Sports Grants

Intake: Varies

Funding opportunities for projects in the areas of arts, culture, community, heritage, recreation, sport, and diversity and inclusion.

Government of Alberta – Building Blocks Capital Grant Program

Intake: Closed

A grant for new, accessible, high-quality and inclusive licensed childcare spaces in facility-based child care programs.

Government of Alberta - Community Initiatives Program (CIP)

Intake: Deadlines - January 15, May 15, September 15, 2025 This program provides funding to new community-based programs, initiatives, events and publications.

Government of Alberta - Community Revitalization Levy

Intake: Open

Allows municipalities to borrow against future property tax revenues to help pay for infrastructure development required in a specific area. The levy is typically in place for 20 years, and no longer than 40 years.

Government of Alberta - Economic Development Funding and Grants

Intake: Varies

Tax credits, grants and other funding programs to stimulate regional economic development.

NEW Government of Alberta – Employment Pathway Grant

Intake: Open

Get funding to train and onboard new and future Class 1 drivers, helping to grow Alberta's transportation workforce.

Government of Alberta - Film and Television Tax Credit

Intake: Open

Tax credit to support medium and large-scale productions filming in Alberta.

Government of Alberta - First Nations Development Fund

Intake: Ongoing (March 31 annual deadline)

Provincial lottery grant program designed specifically for First Nations in Alberta to fund economic, social and community projects.

Government of Alberta - Indigenous Employment Training Partnerships Program

Intake: Open

Indigenous Employment Training Partnerships provides grant funding to Indigenous communities and organizations to deliver group-training projects designed in partnership with employers and other partners. These partnerships will assist unemployed or under-employed Indigenous individuals to gain the necessary skills training and work experience to obtain and maintain long-term employment.

Government of Alberta - Indigenous Reconciliation Initiative

Intake: Closes Sept 15, 2025

The Indigenous Reconciliation Initiative provides funding up to \$100,000 for cultural or economic projects through two streams.

Government of Alberta- Innovation Employment Grant

Intake: Open

Companies can receive a grant of up to 20% toward qualifying research and development expenditures.

NEW Industry Advancement Grant

Intake: Open

Get funding for industry-driven solutions to increase employment, attraction, retention and diversification of the commercial driving industry in Alberta.

Government of Alberta - On-Farm Efficiency Program

Intake: Closed (Re-open April 2026)

Support producers in achieving environmental benefits by improving the efficient use of agricultural inputs.

Government of Alberta - Resiliency and Public Trust Program

Intake: Open

The Resiliency and Public Trust Program enables stakeholders to gain resiliency and build public trust in Alberta's agriculture and agri-food sectors. This includes opportunities for better awareness and education about industry best practices and the development, adoption and enhancement of assurance systems that will help to build trust and resiliency in the industry.

Government of Alberta - Strategic Transportation Infrastructure Program

Intake: Ongoing (November 30 annual deadline)

The Strategic Transportation Infrastructure Program (STIP) provides financial assistance to rural and smaller urban municipalities for developing and maintaining key transportation infrastructure. STIP supports municipalities as they complete projects that improve accessibility and the movement of goods to market, increase opportunities for economic growth and enhance safety and efficiency while extending the life of key transportation infrastructure.

Government of Alberta - Sustainable Canadian Agricultural Partnership (Sustainable CAP)

Intake: Varies

The new \$3.5-billion, 5-year agreement (April 1, 2023, to March 31, 2028), between the federal, provincial and territorial governments to strengthen the competitiveness, innovation, and resiliency of the agriculture, agri-food and agri-based products sector.

- NEW On-Farm Value-Added: Open Supports primary producers in adding value to their agricultural.
- NEW Value-Added Program: Open Invests in projects that increase company sales and production capacity, expand

Government of Alberta - Water for Life program

Intake: Ongoing (November 30 annual deadline)

Municipalities can apply for funding for new regional water supply and treatment facilities, and wastewater treatment facilities.

Government of Alberta- Watershed Resiliency and Restoration Program

Intake: Check back in spring/summer 2025

The Watershed Resiliency and Restoration Program increases the natural ability of the province's watersheds to reduce the intensity, magnitude, duration, and effects of flooding and drought through watershed mitigation measures. Municipalities and non-profit organizations can apply for funding for projects that will enhance communities' ability to withstand future flooding or droughts and promotes the ongoing stewardship and preservation of Alberta's watersheds.

Government of Alberta - Workforce Partnerships Grants

Intake: Closed

Eligible organizations with common labour market needs can get funding to support workforce initiatives.

Government of Alberta - Workforce Strategies Grant

Intake: Closed

As part of Alberta at Work, Workforce Strategies grants support organizations with innovative solutions that will help Albertans develop new skills and assist employers and industry to grow their workforce.

Government of Canada/PrairiesCan Funding Programs Intake: Varies Funding for businesses and not-for-profit organizations with projects that advance economic growth and diversity in the Prairie provinces: Alberta, Saskatchewan and Manitoba.

- PrairiesCan Regional Artificial Intelligence Initiative (RAII) in the Prairie Provinces: Open This funding, delivered by Canada's regional development agencies (RDAs) is available in all regions to help bring new AI technologies to market and speed-up AI adoption in critical sectors such as agriculture, clean technology, healthcare and manufacturing.
- PrairiesCan Regional Homebuilding Innovation Initiative (RHII) in the Prairie Provinces: Open The RHII aims to change the way houses are built and provide more Canadians with a place to call home faster.

Government of Canada- Active Transportation Fund

Intake: Closed



Dear Division Commanding Officer Daroux,

On behalf of Smoky Lake County Council, I am writing to express our interest in exploring how the County can assist the Smoky Lake RCMP Detachment in acquiring a Remotely Piloted Aircraft System (RPAS).

While we recognize that, as an exclusively Police Provincial Service Agreement (PPSA) Detachment, direct County funding for an RPAS may not be feasible under current arrangements, we believe that community-driven priorities and evolving rural policing needs warrant serious consideration of this technology. To that end, we respectfully request that this letter be shared with the appropriate decision-making authorities within the RCMP, including the Operational Strategy Branch (OSB), to help inform ongoing planning and resourcing discussions.

We understand the potential value of RPAS technology in enhancing rural crime prevention, search and rescue, traffic enforcement, and situational awareness. Our intent in raising this matter is to support the Commanding Officer and CROPS Officer in their engagements with the Province by providing concrete examples of local interest and community expectations around the modernization of policing tools and methods.

We look forward to continued collaboration with the Smoky Lake Detachment and your Division leadership as we work toward public safety solutions that reflect the realities of rural Alberta.
